ORDINANCE NO. 154

AN ORDINANCE LICENSING FOR PURPOSE OF REGULATING AND REVENUE, CERTAIN BUSINESS CARRIED ON WITHIN THE CORPORATE LIMITS OF THE TOWN OF GRANITE FALLS, REQUIRING INSPECTION THEREOF, APPOINTING AN INSPECTOR THEREFOR, ESTABLISHING FEES FOR SUCH LICENSES AND FOR THE COLLECTION OF THE SAME AND PROVIDING PENALTIES FOR VIOLATION OF THIS ORDINANCE, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED by the Town Council of the Town of Granite Falls, Washington:

Section 1: The health and welfare of the inhabitants of the Town of Granite Falls is of first importance and depends upon the quality and cleanliness of and freedom from harmful substances in and the preparation under sanitary conditions of food furnished such inhabitants.

Section 2: No person, firm, or corporation shall operate any bakery or engage in the manufacture or delivery within the Town of Granite Falls, Washington, of any bread, pastry, rolls, cakes, pies, or fresh bakery products for sale without obtaining a license from the Town of Granite Falls as herein required, and no person, firm or corporation shall receive, sell, offer or expose for sale within the Town of Granite Falls any bread, pastry, rolls, cakes, pies or fresh bakery products baked and manufactured or delivered by any person, firm, or corporation not having obtained a manufacturer's or delivery license and thereby become subject to inspection as required by the other terms of this Ordinance, provided however, no person, firm or corporation operating a retail store in the Town of Granite Falls shall be required to obtain a license to make retail deliveries to purchasers within said Town of any bread, pastry, rolls, cakes, pies or fresh bakery products sold at retail.

Section 3: Every person, firm, or corporation which shall desire to operate any bakery or engage in the manufacture or delivery for sale within the Town of Granite Falls, Washington, of any bread, pastry, rolls, cakes, pies or

fresh bakery products, shall pay to the Town Clerk a fee of \$50.00 for a license so to do, upon which payment such license shall be issued for a period terminating December 31st next after date of such application, and said license may be renewed from year to year thereafter upon payment of a similar fee.

Section 4: The Town Marshal of the Town of Granite Falls is hereby appointed as inspector for bakeries and bakery products and he shall inspect all bakeries within the Town of Granite Falls and all vehicles in which delivery of the bakery products mentioned in this ordinance are delivered in the Town of Granite Falls at least once each month and if he finds any unsanitary condition to exist he shall report such condition and finding to the operator of such bakery or vehicle and to the Town Clerk and if such unsanitary condition is not immediately removed and remedied the Town Council of the Town of Granite Falls may at its next meeting suspend the license held by such operator. If such operator does not apply to the Council and receive reinstatement within thirty days thereafter the license shall, by resolution of the Council, be cancelled. The inspector shall be paid by the Town a fee of \$1.00 for each inspection, which shall be paid from the current expense fund of said Town, and upon said inspection being made shall issue a duplicate certificate; one to the party inspected and the other to the Town Clerk certifying his finding upon such inspection.

Section 5: Upon payment of each license fee the Town Clerk shall issue a receipt and a license and upon payment of an additional sum of \$1.00 each shall issue additional copies of said license bearing the number of the original license; the copies shall be used and placed in a conspicuous place upon each vehicle used by the licensee to make delivery of such products and each person, firm or corporation operating a vehicle making delivery of such ordinance becomes effective, obtain and display upon such vehicle in a conspicuous place, the license so obtained; failure to display the same or the operation of any vehicle in making delivery of such bakery products within the Town of Granite Falls after this ordinance becomes effective without having displayed thereon in a conspicuous place such license, shall be deemed a violation hereof and each day's operation without such license shall be a separate offense.

Section 6: The Town Clerk, in issuing any license hereunder shall credit against the fee charged therefor, all real estate and personal property taxes paid by the

applicant upon property situated in the Town of Granite Falls and which have been paid within one year of the Treasurer of Snohomish County therefor shall be sufficient evidence to present to the Town Clerk for such purpose; provided, however, that in no event shall a license be issued for less than \$5.00.

Section 7: Any person, firm, or corporation violating any of the sections or provisions of this ordinance shall be guilty of a misdemeanor and upon conviction shall be fined not to exceed the sum of \$100.00 for each such offense.

Section 8: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 9: If any section of this ordinance be declared invalid for any reason, such invalidity shall not affect the remaining sections or provisions of this ordinance.

Section 10: This ordinance shall be in full force and effect from and after its passage and publication according to law.
