ORDINANCE NO. 181

AN ORDINANCE SETTING FORTH REASONS FOR AN INCREASE IN, AND FIXING THE RATES FOR WATER SUPPLIED BY THE MUNICIPAL WATER WORKS OF THE TOWN OF GRANITE FALLS, WASHINGTON, AND PROVIDING FOR A PENALTY OF NON-PAYMENT OF SAID WATER RATES UNDER CONDITIONS HEREIN PRESCRIBED.

BE IT ORDAINED by the town Council of the Town of Granite Falls, Washington:

Section 1: That due to increase cost of labor and materials, and an increase in the Bonded indebtedness and interest covering cost of materials and labor or replacing all existing water mains, valves, etc., and providing a sinking fund to redeem the outstanding bonds as they become due and paying interest on the same.

Section 2: The monthly rates for water shall be as follows:

Section 3: A penalty of 25 Cents will be charged for each month of delinquent water if not paid by the 10th day of each month of which same is due.

Section 4: All ordinances and parts of ordinances in conflict herewith are repealed.

Section 5: This ordinance deemed an emergency ordinance for the welfare of citizens living within the corporate limits of the town and shall become effective on and after the 16th day of June.
