

ORDINANCE NO. 204

AN ORDINANCE CREATING A SEWER SYSTEM; ADOPTING A PLAN FOR THE CONSTRUCTION OF A SEWAGE DISPOSAL SYSTEM; DECLARING COSTS; PROVIDING FOR THE ISSUANCE OF REVENUE BONDS BY SUBSEQUENT ORDINANCE AND AUTHORIZING THE PURCHASE OF REAL PROPERTY.

WHEREAS, the Town of Granite Falls has by Ordinance No. 200 provided for the fixing of rates and charges for sewer services and created a fund known as Sewer Revenue Fund, and

WHEREAS, the Commissioners of the Town of Granite Falls deem it necessary for the public health and safety that a sewage disposal plant and system is constructed,

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF GRANITE FALLS:

Section 1: That a sewer system is hereby created which shall be operated under the direction of the Superintendent of streets and pursuant to the orders of the Town Council of Granite Falls and in accordance with Ordinance No. 200 of the Town of Granite Falls.

Section 2: That the public health and safety requires and it is deemed advisable that the Town of Granite Falls construct and operate a system of sewage disposal.

Section 3: That the following described plan or system for the construction of a sewage disposal system is hereby adopted:

A. Acquisition of sewage treatment plant site consisting of:

That portion of the West 300 feet of the South 1/2 of the South 1/2 of the NW 1/4 of the NE 1/4, less the North 30 feet thereof, together with the West 300 feet of the SW 1/4 of the NE 1/4, Section 24, TWP. 30 North, Range 6 East, W.M., all lying northerly of the Pilchuck River, said tract comprising 2 acres.

B. Construction of a primary type sewage treatment plant and appurtenances, including influent and effluent sewers, on said treatment plant site.

C. Construction of a first phase of a storm sewer program for diversion of surface water from a sanitary sewer system to consist of a 24 inch storm sewer approximately 300 lineal feet in length, on Union Street, extending easterly from the westerly side of Cascade Avenue.

D. Acquisition of necessary rights-of-way on easements.

That the life expectancy of the improvement will be in excess of thirty years.

Section 4: That the estimated cost of said sewage disposal system is hereby declared, as nearly as may be, to be the sum of \$34,000.00.

Section 5: That the cost of construction of said sewage disposal system shall be defrayed as follows:

Funds available on hand in sewer revenue fund	\$10,000.00
Grants-- Federal or State	9,000.00
Revenue Bonds	<u>15,000.00</u>
	\$34,000.00

Section 6: That in order to secure funds for the payment of a portion of the proposed plan for the construction of a sewage disposal system, the Town of Granite Falls shall issue and sell its sewer revenue bonds in the principal amount of approximately \$15,000.00. The exact principal amount of the bonds, the date of issue, interest rate, maturities, form and terms thereof shall be as hereinafter fixed by ordinance.

Section 7: That the Mayor of the Town of Granite Falls, with the approval of the Town Council, is hereby directed to purchase the following described property, to wit:

That portion of the West 300 feet of the South 1/2 of the South 1/2 of the NW 1/4 of the NE 1/4, less the North 30 feet thereof, together with the West 300 feet of the SW 1/4 of the NE 1/4, Section 24, TWP. 30 North, Range 6 East, W.M., all lying northerly of the Pilchuck River, said tract comprising 2 acres.

as a site for the construction of the proposed sewage disposal plant, together with all other necessary easements and rights-of-way for the construction of the proposed project, and to proceed with the construction of the sewage disposal system as soon as funds are available as heretofore proposed.

Section 8: That all funds received from grants or otherwise shall be held in the Sewer Revenue Fund created by Ordinance No. 200 of the Town of Granite Falls.
