

TOWN OF GRANITE FALLS

ORDINANCE NO. 287

AN ORDINANCE AMENDING AND ESTABLISHING CHARGES FOR WATER SERVICE WITHIN AND ABOUT THE TOWN OF GRANITE FALLS, AND REPEALING ALL OTHER ORDINANCES AND SECTIONS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF GRANITE FALLS:

- Section 1. Ordinances Nos. $_{65}$, $_{181m}$ and $_{230}$ are hereby amended as the same refer to rates charged for water service.
- Section 2. The following rates will apply to all metered water users:
 - \$5.50 per month for 3/4-inch service line; minimum of 600 cubic feet; \$.12 per 100-foot excess.
 - \$8.80 per month for 1-inch service line; minimum of 1100 cubic feet; \$.12 per 100-foot excess.
 - \$24.20 per month for 1-1/2 inch service line; minimum of 3500 cubic feet; \$.12 per 100-foot excess
 - \$44.00 per month for 2-inch service line; minimum of 6500 cubic feet; \$.12 per 100-foot excess
 - \$71.50 per month for 2-1/2 inch service line; minimum of 10,750 cubic feet; \$.12 per 100-foot excess
 - \$93.50 per month for 3-inch service line; minimum of 15,000 cubic feet; \$.12 per 100-foot excess.
- Section 3. The following rates will apply to all non-metered commercial water users:
 - \$6.60 per month for 3/4-inch or less service line;
 - \$11.55 per month for 1-inch service line
 - \$36.30 per month for 1-1/2 inch service line
 - \$66.00 per month for 2-inch service line
 - \$140.25 per month for 3-inch service line

- Section 4. The following monthly charges will apply to each living unit and/or non-commercial hookup to the water system of the Town of Granite Falls which is not served by a meter:
 - 4.1 Single-Family Dwelling: \$5.50 per month
 - 4.2 <u>Duplex</u>, Triplex, Fourplex, and Other Apartments: \$5.50 per month per living unit
 - 4.3 Mobile Homes and Trailers Connected to Water: \$5.50 per month
 - 4.4 Churches and Other Non-Profit Public Meeting Places:

\$5.50 per month

- 4.5 Single-Family and Multiple Dwelling Units Located Outside The Town Limits: \$6.20 per month per living unit.
- 4.6 All Others: \$5.50 per month
- Section 5. Hookup Charge: There shall be a water hookup charge of \$200 per unit plus costs of labor and materials.
- Section 6. Delinquency Charge: If a water bill is two months delinquent, at the end of the two months a fine of \$.25 will be due after the tenth of each month.
- Section 7. All charges for water service shall be billed to the property owner rather than the tenant for collection.
- Section 8. A charge of \$11.00 will be made to turn on water service which has been disconnected for failure to pay.
- Section 9. Effective Date: This Ordinance shall take effect from and after the 23 day of April , 1980.
- Section 10. If any provision of this Ordinance or its application to any person or circumstances is held invalid, the remainder of the Ordinance, or the application of the provision to other persons or circumstances, is not affected.
