TOWN OF GRANITE FALLS ORDINANCE NO. 303

AN ORDINANCE AMENDING AND ESTABLISHING CHARGES FOR SEWER SERVICE WITHIN AND ABOUT THE TOWN OF GRANITE FALLS, AND REPEALING ALL OTHER ORDINANCES AND SECTIONS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF GRANITE FALLS, SNOHOMISH COUNTY, WASHINGTON:

Section 1. Ordinance Nos. and are hereby amended as the same refer to rates charged for sewer service.

Section 2. The following charges shall be established for sewage treatment and disposal service. Each and every person making use of the Town of Granite Falls sewer shall pay for the same on a residential unit price which shall be established at \$12.00 per unit, per month.

The user charges shall be levied on all users of the public treatment works, which shall cover the cost of operation and maintenance, debt service, taxes and other administrative costs of such treatment works. The user charge system shall distribute these costs in proportion to each user's contribution to that wastewater loading on the treatment works.

The following monthly rate schedule for sewage treatment and disposal service shall apply:

Rates for all establishments not herein covered will be negotiated between such establishments and the Town of Granite Falls. Negotiations shall include a review of water consumption rates.

The sewer user charges established in this Ordinance shall, as a minimum, be reviewed annually and revised periodically to reflect actual costs of operation, maintenance, replacement, and financing of the treatment works and to maintain the equitability of the user charges with respect to proportional distribution of the costs of operation and maintenance in proportion to each user's contribution to the total wastewater loading of the treatment works.

- Section 3. All charges for sewer service shall be billed to the property owner, rather than the tenant, for collection.
- Section 4. Delinquency Charge: If a sewer bill is two months delinquent, at the end of the two months, a fine of \$ will be due after the tenth of each month.
- Section 5. Hookup Charge: There shall be a sewer hookup charge of \$200 per unit, plus costs of labor and materials.
- Section 6. Effective Date: This Ordinance shall take effect from and after the 22 day of April , 1981.
- Section 7. Severability: If any provision of this Ordinance or its application to any person or circumstances is held invalid, the remainder of the Ordinance, or the application of the provision to other persons or
