

CITY OF GRANITE FALLS

ORDINANCE NO. 670-03

AN ORDINANCE OF THE CITY OF GRANITE FALLS
VACATING A PORTION OF NORTH INDIANA AVENUE
AS FURTHER DESCRIBED BELOW AND SHOWN ON
THE ATTACHED MAP.

WHEREAS, the City of Granite Falls is proposing vacation of a portion of North Indiana Avenue; and

WHEREAS, the street being vacated is more accurately described as follows:

Commencing at a point on the East margin of Kentucky Avenue 721 feet East and 225 feet North of the Southwest corner of Government Lot 3, Section 18, Township 30 North, Range 7 East, Willamette Meridian, Snohomish County, Washington;

Thence North 160 feet, along the East margin of Kentucky Avenue, to the centerline of that street as laid out in the Plat of Granite Falls and vacated per Ordinance No. 145, records of the City of Granite Falls;

Thence East 133 feet along the centerline of said vacated street;

Thence South to the South margin of said vacated street;

Thence East 125 feet, along said South margin to the West margin on Indiana Avenue and the Point of Beginning;

Thence South along said West margin 145 feet;

Thence East, perpendicular to said West margin to the East margin of said Indiana Avenue;

Thence North along said East margin 145 feet, to the South margin of said vacated street;

Thence West along said South margin to the Point of Beginning.

WHEREAS, the City Council declare that the road is not necessary as a part of the general road system and the public will not be inconvenienced by its vacation; and


WHEREAS, a Public Hearing was held n the 26th day of February 2003, before the City Council of the City of Granite Falls, Washington, at the Council Chambers at the City Hall.

NOR, THEREFORE, BE IT DORAINED BY THE COUNCIL OF THE CITY OF GRANITE FALLS, WASHINGTON, as follows:

Section 1. The portion of North Indiana, as described above and shown on the attached map, all within the City of Granite Falls, is hereby vacated.


Section 2. This Ordinance shall become effective upon its passage, publication, and posting, according to law.

THIS ORDINANCE IS HEREBY ADOPTED by the City of Granite Falls this 25 day of June, 2003.






