ORDINANCE NO. 787-2009

AN ORDINANCE OF THE CITY OF GRANITE FALLS, WASHINGTON,
AMENDING ORDINANCE NO. 773-08 ADOPTING THE 2009 BUDGET
TO ADJUST REVENUE ESTIMATES AND APPROPRIATIONS FOR
THE GENERAL FUND AND THE EQUIPMENT FUND;
TO ADJUST APPROPRIATIONS FOR THE ALTERNATE ROUTE CIF FUND, THE WATER FUND,
THE WATER CIF FUND, THE SEWER CIF FUND, AND THE STORM DRAINAGE FUND

WHEREAS, the City Council of the City of Granite Falls, Washington (the "City") did adopt Ordinance No. 773-08 establishing the 2009 Budget for the City on December 30, 2008; and

WHEREAS, the amount of revenue and appropriations can only be estimated at the time of finalization of the budget; and

WHEREAS, the City Council finds it in the best interest of the City of Granite Falls to adjust revenue estimates and appropriations in the General Fund and the Equipment Fund; and appropriations in the Alternate Route CIF Fund, the Water Fund, the Water CIF Fund, the Sewer CIF Fund, the Storm Drainage Fund;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS, WASHINGTON, DOES ORDAIN AS FOLLOWS:

<u>Section 1. Funds Appropriated</u> The 2009 annual budget, adopted by Ordinance No. 773-08, for the period January 1, 2009 through December 31, 2009, is hereby amended by fund to reflect the adjustments to revenue estimates and appropriations as follows:

<u>Section 2. Severability.</u> Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of the Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

<u>Section 3. Effective Date.</u> This ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of the publication.
