CITY OF GRANITE FALLS ORDINANCE NO. 791-2009

AN ORDINANCE OF THE CITY OF GRANITE FALLS, WASHINGTON REPEALING ORDINANCE NO. 788-2009 AND ADOPTING THE CORRECTED 2010 ANNUAL BUDGET PROVIDING ESTIMATED REVENUES AND APPROPRIATED EXPENDITURES FOR THE OPERATION OF THE CITY.

WHEREAS, State law requires cities to adopt a 2010 budget no later than December 31, 2009, and provides procedures for filing estimates, a preliminary budget, public hearings, and final fixing of the budget; and

WHEREAS, the City Council held workshops and invited public comment on the preliminary budget on September 24, 2009, October 21, 2009, October 26, 2009, November 12, 2009 and November 24, 2009; and

WHEREAS, the 2010 proposed budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the City of Granite Falls (the "City") for the purposes set forth in said budget. The estimated expenditures set forth in the budget being all necessary to carry on the government of the City for the 2010 calendar year and being sufficient to meet the various needs of said city during said period; and

WHEREAS, the City Council after due notice, held a public hearing on November 4, 2009 and December 2, 2009 to consider 2010 revenue sources and expenditure appropriations for the year 2010; and

WHEREAS, the City Council has deliberated on the proposed 2010 budget and made adjustments and changes deemed necessary and proper; and

WHEREAS, Ordinance 788-2009, adopting the 2010 budget, contained an arithmetic error that has been corrected in the budget set forth below;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Repealer. Ordinance 788-2009 is hereby repealed.

<u>Section 2</u>. <u>Adoption by Reference</u>. The annual budget for the City of Granite Falls, Washington, for the year 2010 is hereby adopted at the fund level in its final form and content as set forth in the document entitled City of Granite Falls 2010 Annual Budget, one copy of which is on file in the Office of the Clerk.

<u>Section 3.</u> <u>Resources and Expenditures.</u> Estimated resources for each separate fund of the City of Granite Falls, and aggregate expenditures for all such funds for the year 2010 are set forth in summary form below, and are hereby appropriated for expenditure at the fund level during the year 2010 as set forth in the City of Granite Falls 2010 Annual Budget.

Severability.</u> If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

<u>Section 5. Publication and Summary.</u> This Ordinance or summary thereof consisting of the title shall be published in the official newspaper of the City.

<u>Section 6. Effective Date.</u> This Ordinance shall be in full force and effect five (5) days after publication of the summary consisting of the title.
