CITY OF GRANITE FALLS ORDINANCE NO. 771-08

AN ORDINANCE OF THE CITY OF GRANITE FALLS REPEALING ORDINANCE NO. 426 AND AMENDING CHAPTER 3.28 OF THE GRANITE FALLS MUNICIPAL CODE RELATING TO ESTABLISHING A RETURN CHECK FEE OF \$35.00 PER CHECK ON CHECKS RETURNED DUE TO NON-SUFFICIENT FUNDS (NSF).

WHEREAS, the Granite Falls City Council feels the implementation of a fee for NSF checks will discourage issuance of these checks; and

WHEREAS, extra costs are incurred by the City of Granite Falls for the administration involved in collection of these checks; and

WHEREAS, the City of Granite Falls fee for checks returned due to non-sufficient funds has not been modified or adjusted since 1989; and

WHEREAS, administrative costs to collect checks returned due to non-sufficient funds have increased substantially since 1989;

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS, WASHINGTON, DO ORDAIN AS FOLLOWS:

Granite Falls Municipal Code Chapter 3.28 is hereby amended to read as **Section 1:** follows:

CHECKS RETURNED FOR NON-SUFFICIENT FUNDS

Sections:

3.28.010

Fee for returned checks.

3.28.020

Deposit of proceeds.

Fee for returned checks. There is established a fee of \$35.00 per check 3.28.010 on checks returned due to Non-Sufficient Funds (NSF).

Deposit of proceeds. Proceeds collected from this fee shall be deposited 3.28.020 into the Current Expense Fund.

Repealer. Ordinance No. 426 is hereby repealed in its entirety. **Section 2:**

- Section 3: Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.
- Section 4. <u>Publication and Summary.</u> This Ordinance shall be in full force and effect five (5) days after publication of a summary thereof consisting of the title.
