**ORDINANCE NO. 806-2010**

**AN ORDINANCE OF THE CITY OF GRANITE FALLS, WASHINGTON,  
AMENDING ORDINANCE NO. 791-2009 ADOPTING THE 2010 BUDGET  
TO ADJUST REVENUE ESTIMATES AND APPROPRIATIONS FOR  
THE GENERAL FUND AND THE LIBRARY FUND;**

**WHEREAS**, the City Council of the City of Granite Falls, Washington (the "City") did adopt Ordinance No. 791-2009 establishing the 2010 Budget for the City on December 30, 2009; and

**WHEREAS**, the amount of revenue and appropriations can only be estimated at the time of finalization of the budget; and

**WHEREAS**, the City Council finds it necessary for the City of Granite Falls to account for an interfund loan to the General Fund from the Water Fund; and provide revenue and appropriations to account for an equity transfer of funds from the Library Fund to the General Fund; and to account for a reduction in grant revenue from the Drug Task Force.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS, WASHINGTON, DOES ORDAIN AS FOLLOWS:**

**Section 1. Funds Appropriated** The 2010 annual budget, adopted by Ordinance No. 791-2009, for the period January 1, 2010 through December 31, 2010, is hereby amended by fund to reflect the adjustments to revenue estimates and appropriations as follows:

**Section 2. Severability.** Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of the Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.


**Section 3. Effective Date.** This ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of the publication.
