**ORDINANCE NO. 875-2014**

**AN ORDINANCE OF THE CITY OF GRANITE FALLS, WASHINGTON AMENDING GFMC 2.08.070 (B) TO REVISE THE DATES AND START TIME OF THE REGULAR MEETINGS OF THE CITY COUNCIL TO 7:00 PM ON THE FIRST AND THIRD WEDNESDAYS OF THE MONTH WITH A WORKSHOP ON THE SECOND WEDNESDAY AND REPEALING ANY INCONSISTENT PROVISION IN ORDINANCE NO. 776-09 AND 864-2014.**

**WHEREAS**, the City Council wishes to change the date of the regular meetings of the city council;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS DOES HEREBY ORDAIN AS FOLLOWS:**

**Section 1.** Current GFMC Section 2.08.070(B) is hereby amended to read as follows:

(B) Time and Place – Legal Holidays. Regular meetings of the council shall be held on the first and third Wednesdays of each month at the hour of 7:00 p.m., and a regular work session meeting on the second Wednesday of each month at the hour of 7:00p.m. The meetings shall be held in the council chambers of City Hall, 206 S. Granite Ave., Granite Falls, Washington, and shall be open to the public. Regular meetings may be adjourned from time to time during the month, as necessity may require, by the majority vote of the council members present at any such regular meeting. Less than a quorum of the governing body may also adjourn from time to time, and if all members are absent from any regular or adjourned meeting, the city clerk may declare the meeting adjourned to a stated time and place and provide notice in accordance with RCW 42.30.080 and 42.30.090. In the event a regular meeting of the council occurs on a legal holiday, the council shall hold its regular meeting on the next secular day following the legal holiday


**Section 2.** Any provision inconsistent with this Ordinance in Ordinance 776-09 or Ordinance 864-2014 is hereby repealed.

**Section 3.** If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.


**Section 4.** This Ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the City.


**Section 5.** This Ordinance shall be in full force and effect five (5) days after its publication or publication of the summary consisting of the title.
