ORDINANCE NO. 866-2014

AN ORDINANCE OF THE CITY OF GRANITE FALLS, WASHINGTON AMENDING GFMC 13.02.102 TO PROVIDE FOR THE PAYMENT OF THE CITY'S SEWER CONNECTION CHARGE (GENERAL FACILITY CHARGE) AT THE TIME OF BUILDING PERMIT ISSUANCE, AND REPEALING ANY INCONSISTENT PROVISION IN ORDINANCES 802, 719, 671, 610, 503, 389 AND 304.

WHEREAS, the City wishes to provide that its Sewer Connection Charge (General Facility Charge) is due at the time of building permit issuance;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Current GFMC Section 13.02.102 is hereby amended to read as follows:

13.02.102 Rates and charges- Connection charge - Collection

There shall be a sewer connection charge (general facility charge) collected, per unit in an amount as established by resolution of the city council. The sewer connection charge (general facility charge) shall be due and payable at the time of building permit issuance or connection, whichever is earlier.

- Section 2. Any provision inconsistent with this Ordinance in Ordinances 802, 719. 671, 610. 503, 389, and 303 is hereby repealed.
- <u>Section 3</u>. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.
- <u>Section 4</u>. This Ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the City.
- <u>Section 5</u>. This Ordinance shall be in full force and effect five (5) days after its publication or publication of the summary consisting of the title.
