## CITY OF GRANITE FALLS

## **ORDINANCE NO. 871-2014**

AN ORDINANCE OF THE CITY OF GRANITE FALLS, ADOPTING THE CITY OF GRANITE FALLS MUNICIPAL CODE UPDATE ENTITLED CITY OF GRANITE FALLS MUNICIPAL CODE DRAFT - MARCH 27, 2014; AND PROVIDING FOR SEVERABILITY AND EFFECTIVE DATE.

WHEREAS, the City found that the general ordinances of the City of Granite Falls as codified were incomplete and inadequate to meet the immediate needs of the City; and

WHEREAS, the City contracted with Code Publishing Co. to provide for a recodification and republishing of the Granite Falls Municipal Code; and

WHEREAS, City staff and City Attorneys have also reviewed the Granite Falls Municipal Code for updating, recodification and republishing; and

WHEREAS, Code Publishing Co. provided the City with the City of Granite Falls Municipal Code Draft - March 27, 2014; and

WHEREAS, the City of Granite Falls had first reading of this Ordinance on April 16, 2014 and pursuant to RCW 35.21.530 after first reading, set a Public Hearing on May 5, 2014 to adopt Granite Falls Municipal Code Draft - March 27, 2014 as the updated codification of the Granite Falls Municipal Code. A printed copy of the code is on file in the City Clerk's office available for inspection.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Adoption of Municipal Code. The City of Granite Falls hereby adopts the Granite Falls Municipal Code Draft - March 27, 2014 as attached as EXHIBIT A and incorporated herein by reference as the official municipal code of the City of Granite Falls to be known as the Granite Falls Municipal Code.

Section 2. Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

**Section 3. Effective Date.** This ordinance shall take effect five days after the date of its publication by summary.
