A RESOLUTION OF THE CITY OF GRANITE FALLS, WASHINGTON DECLARING AS SURPLUS POLICE VEHICLES

WHEREAS, the City of Granite Falls has entered into an Interlocal Agreement between Snohomish County and City of Granite Falls for Law Enforcement Services; and,

WHEREAS, this Interlocal Agreement became effective as of March 1, 2014; and,

WHEREAS, the City of Granite Falls will no longer have need for the Police Department vehicles currently owned by the City; and,

WHEREAS, the City has obtained Kelly Blue Book trade in value as of December 31, 2013 for the subject vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANITE FALLS AS FOLLOWS:

- <u>Section 1.</u> Police vehicles listed on Exhibit "A" to this Resolution are declared as surplus equipment to the City of Granite Falls.
- <u>Section 2.</u> These surplus vehicles are to be transferred/sold to another government agency at or below reasonable market value; transferred/sold by solicitation of written bids at a reasonable market value; or transferred/sold at public auction at a reasonable market value.
- <u>Section 3.</u> These surplus vehicles are to be transferred/sold in "as is" condition, with no warranty either expressed or implied as to merchantability or suitability for any purpose whatsoever.
- <u>Section 3.</u> If any section, sentence, clause or phrase of this resolution should be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this resolution.

<u>Section 4.</u> This resolution shall take effect immediately upon passage by the City of Granite Falls City Council. _
