PROPOSED PROJECT DESCRIPTION: The site area is 45,302 sf (gross) GC zoned. The new development will involve construction of a new single story (Approx. 4638 sf.) wood, frame, stucco, Hardie Siding finish with kitchen, hot food equipment (Approx. 500 sf.)., convenience store with slab on grade. It will be Type VB construction for wood walls to convenience store. The site will also include two gas canopies with total six gas/diesel dispensers including underground storage tanks. The project proposal will site development to City of Granite Falls development standards and within the constraints allowed.

**PERMITS REQUIRED/REVIEW PROCESS:** Site plan review, construction plans approval, and building permit approval. Site plan review as a Type II administrative decisions. No public hearing is required for this action
