ORDINANCE NO. 1031-2022

AN ORDINANCE OF THE CITY OF GRANITE FALLS, WASHINGTON, RELATING TO THE 2022 CITY BUDGET; AND AMENDING ORDINANCE NO. 1017-2021 ADOPTING THE 2022 BUDGET TO ADJUST REVENUE ESTIMATES AND APPROPRIATIONS FOR FUNDS AS INCLUDED ON EXHIBIT "A".

WHEREAS, the City Council of the City of Granite Falls, Washington (the "City") adopted the 2022 Budget by Ordinance No. 1017-2021 on December 1, 2021, establishing necessary and proper allocations for each department and fund; and

WHEREAS, the 2022 Budget previously was amended by Ordinance 1018-2022; and

WHEREAS, the 2022 Budget previously was amended by Ordinance 1022-2022; and

WHEREAS, the 2022 Budget previously was amended by Ordinance 1025-2022; and

WHEREAS, the amount of revenue and appropriation allocations can only be estimated at the time of finalization of the budget;

WHEREAS, the budget includes a list of employee positions and salary scales; and

WHEREAS, the City Council has determined it is necessary to make further adjustments in the budget to adjust the employee positions and establish a salary scale:

 Addition of an exempt Community Development Director position and associated Salary Scale per EXHIBIT A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GRANITE FALLS, WASHINGTON, DO ORDAIN AS FOLLOWS:

- <u>Section 1.</u> <u>Amendment of 2022 Budget and Appropriation of Funds.</u> The 2022 annual budget, adopted by Ordinance No. 1017-2021 for the period January 1, 2022 through December 31, 2022, and previously amended, is hereby amended to reflect the addition of a Community Development Director position in accordance with Exhibit A.
- Section 2. The City Treasurer is hereby authorized and instructed to make the necessary changes to the 2022 annual budget adopted by Ordinance No. 1017-2021 and make any necessary and appropriate line item entries and adjustments in order to reflect the amendments contained in this Ordinance.
- <u>Section 3.</u> Ordinance No. 1017-2021 is hereby amended as necessary to reflect the budget amendments contained in this Ordinance.
