A. AB 104-2022 Consideration of Contract Supplement for additional design services for the Galena St. Extension

Councilmember Griggs moved to approve contract supplement with Gray & Osborne, Inc. for additional design services and authorize City Manager to sign. Councilmember Hogan seconded. Motion carried.

B. AB 105-2022 Consideration of Agreement with Kimley Horn to provide consulting services related to the Transportation Element of the City's 2024 Comprehensive Plan Update

Councilmember Glenn moved to approve the agreement between Kimley Horn and Associates and the City of Granite Falls for Traffic Engineering Services related to the City's transportation element update of its 2024 Comprehensive Plan and authorize the City Manager to sign. Councilmember Hogan seconded. Motion carried.

C. Consideration of Adoption of Ordinance No. 1031-2022, an Ordinance of the City of Granite Falls, Washington, relating to the 2022 City Budget, and amending Ordinance No. 1017-2021 adopting the 2022 Budget to adjust revenue estimates and appropriations for funds as included on Exhibit A.

Councilmember Hogan moved to adopt Ordinance No. 1031-2022, an Ordinance of the City of Granite Falls, Washington, relating to the 2022 City Budget, and amending Ordinance No. 1017-2021 adopting the 2022 Budget to adjust revenue estimates and appropriations for funds as included on Exhibit A. Councilmember Glenn seconded. Motion carried.
